Dr. (Ms.) Seema Chandhok, Deputy Librarian represented Prof. Jaideep Sharma, Librarian and Director, L&DD, IGNOU, who was also invited to present the item regarding MoU with INFLIBNET Centre for Shodhganga/Shodhgangotri (A Repository of Theses and Dissertations submitted to the Universities in India) signed by IGNOU on 01.01.2016.

At the outset, Prof. Nageshwar Rao, Vice Chancellor, IGNOU and Chairman welcomed all the members of the committee. He thanked to the outgoing members for their contribution and welcomed the members of newly constituted committee. He informed that the meeting of RCSC could not be held since September 2014. In between, the term of committee members was over. Hence ,the committee has been reconstituted.

The Chairman also put on record the contributions of Prof. M.S. Nathawat, previous Director, Research Unit and the Convener of the Committee and welcomed Prof. Satyakam, Director, Research Unit, who has recently took over the charge of Research Unit.

The Chairman, in his introductory remarks, highlighted the significance of research programmes of the University. He put on record the steps taken by the university towards restart of its Research Degree Programme which are on hold for quite some time. He informed that IGNOU's new Ordinance on Research Degree Programmes is under submission to MHRD for the Visitor's assent. Since, the University is waiting for the approval from the Ministry, university is taking regular follow up with the Ministry of Human Resource Development and University Grants Commission.

He also informed the committee the discussions held in various meetings at various forums with the Ministry and the UGC regarding university's Research Degree Programme.

The Chairman put on record that university strongly presented its stand before the Committee on New Education Policy, on Research Degree Programmes. The Chairman also assured the Council that necessary steps would be taken to facilitate the researchers. The Members of the Research Council Standing Committee endorsed the views of the Chairman and requested him to initiate appropriate steps in this regard.

Director, Research Unit further informed the members that Progress Reports of the students have duly been approved by the concerned Doctoral Research Committee (DRC) and subsequently by the School Board of the concerned School. The Research Supervisors had expressed their satisfaction over the progress of the student(s). The original progress reports and concerned minutes of concerned Doctoral Research Committee and School Board were placed before the committee.

Members expressed that as per the appendix(s) provided either names of students /enrollment numbers/programme/research topic or name of the research supervisors etc have not mentioned in case of a few students belonging to certain disciplines/schools

Members also expressed that a few of candidates whose progress reports are being placed, enrolled even in year 2008 and 2009. Hence it was not clear whether the student is still active as the maximum duration of the programme is expired. Whether s/he has been granted extension etc?

Director, Research Unit explained that as the Meeting of the Committee could not be convened for almost last two years, there are a few students whose progress reports are being placed, already awarded the Ph.D. Degree, under process of submission of theses or just waiting to submit theses for the sake of approval of progress reports so that necessary processes may be initiated in this regard.

## Minutes of the 15<sup>th</sup> Meeting of the Research Council Standing Committee

RCSC.15.14.3	The Research Council Standing Committee approved the proposals of all three Faculty Members i.e. Dr. VV Subrahmanyam, Associate Professor, SOCIS, IGNOU; Dr. Sudhanshu Sharma, Asstt. Professor, SOCIS, IGNOU and Dr. Arvind Kumar Dubey, Asstt. Profesor, SOTHSM, IGNOU as Research Supervisors.
<b>RCSC.15.15.</b>	<b>To consider the issue of Provisional Certificate(s) to Ph.D. Holders of the University as per UGC Guidelines 2009.</b>
RCSC.15.15.1	The agenda to consider the issue of Provisional Certificate(s) to Ph.D. Holders of the University as per UGC Guidelines 2009 was placed before the Research Council Standing Committee for consideration and approval.
RCSC.15.15.2	<p>Director, Research Unit and Convener of the Committee informed the members that the Research Unit has been receiving requests from the M.Phil./ Ph.D. holders who have been awarded Ph.D. degree(s) from the University to issue a certificate stating that the Ph.D. Degree awarded to them is in accordance with the 'UGC (Minimum Standards and Procedures for the award of M.Phil and Ph.D. Degree) Regulations, 2009'.</p> <p>He further informed the members that the University has not made fresh admissions for M.Phil/Ph.D. programmes since 2014. For existing students registered for M.Phil./Ph.D. programmes, the University is following all the guidelines of UGC stipulated in 'UGC (Minimum Standards and Procedures for the award of M.Phil and Ph.D. Degree) Regulations, 2009'.</p>
RCSC.15.15.3	<p>The Research Council Standing Committee deliberated the matter in detail and decided that a certificate be issued to the existing students who have been awarded M.Phil./ Ph.D. degrees by the University.</p> <p>Part Minutes were issued on 07.03.2016 with the approval of Hon'ble Vice Chancellor, IGNOU.</p>
<b>RCSC.15.16.</b>	<b>Any other item with the approval of Chair.</b>
RCSC.15.16.1	With approval of the Chairman ,the item regarding request for change of Supervisor and Re-registration of Ms. Rashmi Gautam to the PhD Programme in Tourism Studies of SOTHSM was placed before the Research Council Standing Committee for consideration and approval.
RCSC.15.16.2	<p>Director Research Unit informed the members that Ms. Rashmi Gautam was registered for PhD Programme in School of Tourism and Hospitality Services Management in July 2009. Her maximum time period of registration was valid till June 2014. Her Research Supervisor has recommended for re-registration to the PhD Programme in Tourism Studies vide letter dated 24<sup>th</sup> February 2016.</p> <p>He placed on record that as per provisions contained in the Clause 3.7 of the Ordinance on Research Degree Programmes which says that '<i>the Research Council may consider requests for re-registration from students whose registration is cancelled. An application for re-registration, if made within a period not exceeding</i></p>

	<p><i>six months from the cancellation of the students registration, may be considered on the recommendations of the Supervisor(s) and Area Committee or School Board concerned as the case may be’.</i></p> <p>He further placed on record that the case of Ms. Rashmi Gautam was first placed in 13<sup>th</sup> Research Council Standing Committee held on 30<sup>th</sup> July 2014 for change of Supervisor. The Research Council Standing Committee observed that the student has completed the maximum period of 5 years for completing the PhD Programme as per the Ordinance of Research Degree Programme. After the completion of the stipulated period of registration, the request for change in supervisor requires justification. The comments of the present supervisor be also obtained before change is considered. The agenda item was referred back to the School for its clarification.</p> <p>He also placed on records that the above item was placed again in the Research Council Standing Committee in its 14<sup>th</sup> Meeting held on 16<sup>th</sup> September 2014 and Committee observed the following:</p> <ol style="list-style-type: none"> <li>1. The student worked with the particular Supervisor for around 4 years. On the verge of the completion of the maximum validity period, in the 4<sup>th</sup> year she had requested for change of Supervisor. What was the need and how it was entertained by the Discipline/School concerned?</li> <li>2. Can a student pass judgment on the quality or qualifications of the Supervisor and can pass comments like, “... who can effectively guide me in the area of my research...”. The Committee decided that an explanation note should be sought from the Director of School of Tourism.</li> </ol> <p>In the light of the above observations, the Agenda Item was again referred back to School.</p> <p>Director, Research Unit informed the members that the clarification from the School was sought. It was stated that the earlier Supervisor (External) was changed ‘because there was a serious complaint and we could not put the reputation of University at stake’.</p> <p>He also informed that a communication received from Research Supervisor Prof. Kapil Kumar that the PhD draft thesis of the student has been with him for correction, for a long time and ‘I have been waiting for the clearance to do the same’.</p> <p>Director RU also placed on record that the student has submitted her PhD draft thesis to the Supervisor.</p>
RCSC.15.16.3	Research Council Standing Committee considered and approved the request for change of Supervisor and Re-registration of Ms. Rashmi Gautam to the PhD Programme in Tourism Studies of SOTHSM.

While deliberating upon the agenda(s), members have also observed the following:

- a) While approving the research synopsis and allocating the research supervisor(s) and research topic(s), the Schools/disciplines must ensure that the quality of research must be kept high at par with national/international standards.

- b) Reasons for change of research supervisors or research topic at this later stage were not clear.
- c) As per clause 4.4 of the Research Ordinance of the University later modified by Research Council Standing Committee in its 9<sup>th</sup> Meeting held on 9<sup>th</sup> April 2011 circulated by Research Unit vide its circular date 05.05.2011 that “at any point of time no supervisor should guide more than six (independent)/Twelve (jointly) student”.

The Research council Standing Committee suggested the Research Unit to issue appropriate circular to all the schools in this regard.
