The Committee discussed and deliberated on the research topics at Sl.No. 2 and 3 in the table above proposed and recommended by School of Education which are focused on practices followed by Private Coaching/Tuition Centres. The Committee observed that the School of Education should have identified more relevant research problems focusing more on teaching-learning, pedagogy, learning outcomes, technological interventions, case studies etc and the type of research problems as have been allocated should be avoided. The Committee referred back the research topics allotted at sl no 2 and 3 to SOE for review and resubmission.

The Committee further observed that the research scholars of Geography Discipline, already exempted from coursework from Sl.No. 15 to 22 were allocated Supervisors without being allocated research topics. The committee was of the view that the Doctoral Research Committee should have acted more responsibly by allotting topics and Supervisors at the same time. Taking a view on the allotment of supervisor as per clause 7.1 of IGNOU Research Guidelines that Teachers having less than three years to superannuate may be research co-supervisors and in such cases a research supervisor from among the regular teachers in the discipline shall be allotted to the concerned research student...., the Committee observed that faculty members having less than three years to superannuate had been allotted fresh students. The committee observed that the schools must show greater sensitivity towards compliance of norms in the Ph D programme which is the highest academic qualification. Pointing out the lackadaisical approach on the part of the DRC (s) and School Boards, the Committee asked the Research Unit to communicate the observations of the Committee on the matters pertaining to allotment of research topics and supervisors as an advisory.

In response, the school submitted a justification that Prof. Jaswan Sokhi was associated as a Unit Writer for some courses in the BTS Programme of SOTHSM and she was an expert in the Expert Committee Meeting held for the revision of the courses. The school further mentioned that Prof. Sokhi was working in the area of Cataloguing and studying the Flora and Fauna. Since she was actively involved in the development of tourism course and currently studying the flora and fauna of Sikkim, her name was recommended by the School Board for evaluation of the Thesis.
RCSC 21.9.2	The Committee expressed its concern over the casual approach of the school in proposing and recommending panel of evaluators for evaluation of thesis. The Committee observed that there is no dearth of subject experts in the field of Tourism and the submission of the School in proposing the name of an evaluator from a different field was not justified. The Committee also observed that the concerned DRCs and Schools should be very cautious and careful in recommending names of the evaluators to the competent authority. While recommending names, regional diversity, subject expertise and variety of institutions should be kept in mind which would eventually ensure quality of research and ethical concerns, the Committee viewed.
RCSC 21.9.3	After detailed deliberations, the Committee resolved that in case of the evaluation of thesis of Ms. Dawa Doma Sherpa, PhD scholar of SOTHSM, the School be asked to resubmit the panel of evaluators to the competent authority as soon as possible so that the student should not face any hardship. The Committee also directed the Research Unit to issue an advisory to all the School of Studies to follow standard operating procedure and quality measures in evaluation process of PhD theses.
