

Dr. Satish R. Gaikwad, Deputy Director, Research Unit, assisted the Committee in the entire proceedings of the meeting. The quorum, as per the IEC Standard Operating Procedure (SOP), was duly met.

The Chairperson welcomed all members and appreciated the University's consistent efforts in maintaining high standards of ethical compliance in Ph.D. research. He emphasized that ethical review is integral to ensuring scientific validity and social responsibility in academic research.


The Member Secretary thereafter presented the agenda items and briefed the Committee on the *Standard Operating Procedures (SOP)* of the Institutional Ethics Committee, highlighting key features aligned with the ICMR (Indian Council of Medical Research) Guidelines for human research.

Each Ph.D. scholar, accompanied by their respective supervisor, was invited to present their research proposal before the Committee. After each presentation, the Committee deliberated extensively on the ethical aspects including informed consent, participant safety, confidentiality, translation and cultural adaptation of instruments, and compliance with the Mental Healthcare Act, 2017.

In the case of Ph.D. students supervised by Prof. Swati Patra, the Committee duly noted the potential conflict of interest, and in accordance with the *IEC Standard Operating Procedures* (SOPs), Prof. Swati Patra did not participate in the decision-making process related to those specific proposals. This procedural adherence ensured complete impartiality and ethical compliance in all deliberations.

Following in-depth discussion and expert observations, the Committee made topic-specific recommendations as detailed below:

The Committee collectively emphasized the following overarching ethical principles applicable to all Ph.D. research involving human participants:

- 1. Language and Comprehensibility: All research tools, informed consent participant information sheets must be translated into Hindi or the relevant regional language/dialect using simple, culturally appropriate, and easy-to-understand terminology. The original English version shall first be translated into Hindi/regional language, followed by a back-translation into English to ensure accuracy, semantic equivalence, and cultural appropriateness.
- 2. Confidentiality and Anonymity: Data management systems must ensure encryption, anonymity, and restricted access to identifiers.
- 3. Vulnerability Safeguards: Research involving children, patients, or marginalized populations must include special protective measures and guardian consent.
- 4. Scientific Rigor: Instruments must demonstrate reliability, validity, and cross-cultural adaptability in alignment with recognized research ethics standards.
- 5. **Data Protection:** Scholars must ensure secure digital and physical storage of data with periodic supervisory audit and compliance checks.
- 6. Compliance and Reporting: Any methodological modification post-ethical clearance must be resubmitted to the IEC for review and approval before implementation.
- 7. **Post-Approval Oversight:** Supervisors shall ensure that scholars maintain ethical adherence throughout fieldwork, and any adverse event shall be promptly reported to the IEC.

After extensive deliberation, the Committee approved all eight research proposals for ethical clearance, subject to incorporation of the specific recommendations recorded above.
