At the outset, the Chairman extended a warm welcome to the members of the School Board particularly to the newly appointed members Prof. S. Basu, Prof. Jaswant Sokhi, Dr. O. P. Deval (in absentia) and Dr Vikas Kumar Singh and hoped that their presence and participation will enrich the proceedings of the Board and help the School in planning and implementing its academic activities. The Chairman expressed his gratitude to the following outgoing members for their services to the Board:

SOTST 10.3 Confirmation of the minutes of Ninth School Board Meeting.

- Meeting. Prof. Swaraj Basu suggested that the Minutes of the 1st Board meeting be supplied in advance in future so as to make concrete contribution to the meeting, as it is evident from the minutes that quite a few new programmes are proposed by the School. He suggested that Need Assessment Survey and modular approach and the viability of the courses should be kept in view.
- Prof. Vimal mentioned that these courses would be helpful in bringing SOTST 10.3.2 about and preserving the rich heritage of the country. The Chairman appreciated the word of caution regarding new programmes by Prof. Swaraj Basu. He, however, added that the number of programmes appears large because most of the courses, apart from the courses of the School, are proposed for two new centres: Centre for Sindhi Language and Culture and the Centre for Modern Indian Languages and Mother Tongues. He further added that the suggestions of Prof. Basu will be kept in mind and the issues of new centres and their viability will be sincerely addressed. He further added that the proposed programmes are to be developed in the phased manner, as mentioned in the Minutes of the Advisory Board of the two Centres. As far as the School is concerned, it is focusing on translation programmes which are necessary for the School like Machine Translation, translating Knowledge Texts among others and at the moment the School Faculty is only a coordinating faculty for these programmes.
- SOTST 10.3.3 The Minutes were approved by the Board after the inputs by the members.
- SOTST 10.4 To consider and approve the proposal for conduct of Experts Committee for PG Certificate in Guajarati- Hindi-Translation.
- SOTST 10.4.1 The names of experts were presented to the Board by the concerned Programme Coordinator. The names were approved by the Board. (List Enclosed. Enc. No. 1)
- SOTST 10.5 To consider and approve the proposal for programmes in various languages for Modern Indian Languages and Mother tongues namely (1) Certificate in Awadhi (2) Certificate in Kannada (3) Certificate in Malayalam (4) Certificate in Braj Bhasha (5) Certificate in Gujarati (6) Certificate in Kashmiri (7) Certificate in Himachali Mother-tongues; and (8) Certificate in Santhali.
- SOTST 10.5.1 The Minutes of the meeting held on 12/12/2011 were placed along with the Phase-1 Forms of the programmes before the Board. (Phase 1 forms are enclosed. Enclosure No. 2)
- SOTST 10.5.2 Prof. Vimal expressed his happiness on the inception of the Centre. He added that the Indian Languages and Mother Tongues have been to a

great extent understudied, and IGNOU has taken a good initiative which would help in studying Modern Indian Languages and Mother Tongue and their culture.

- Prof. Harish Trivedi complimented IGNOU authorities for starting the SOTST 10.5.3 Centre. He, however, added that these languages and mother tongues should not be studied in isolation and their inter-lingual linkages should also be studied properly. He said that the inter-lingual studies should also form an integral part of the programmes to be offered.
- The Chairman informed the members that out of 9 programmes SOTST 10.5.4 proposed, the focus in the first phase is on Malayalam, Gujarati, Kashmiri and Awadhi. The preparation will continue for other languages and mother tongues as well. He further added that as mentioned in the Minutes, the focus would be on project-based work leading to documentation of the existing resources and corpus of knowledge in them by finding out a suitable expert/consultant who can complete the work on project basis.
- SOTST 10.5.5 Prof. Jaswant Sokhi stated that these programmes should be prepared by keeping in view the Indians in diaspora and other international academicians interests in the study of these languages and culture. The e-contents of programmes for this purpose should be developed for launching online as well.
- SOTST 10.5.6 The Minutes of the meeting and Phase-1 forms of (1) Certificate in Awadhi (2) Certificate in Kannada (3) Certificate in Malayalam (4) Certificate in Braj Bhasha (5) Certificate in Gujarati (6) Certificate in Kashmiri (7) Certificate in Himachali Mother-tongues; and (8) Certificate in Santhali have been approved by the Board.
- To ratify the Expert Committee for PG Certificate in **SOTST 10.6** Odia-Hindi-English Translation.
