- (a) The grants shall be utilized and disbursed by the concerned implementing agency in accordance with the Operational Guidelines issued for the purpose along with the Administrative Approval for the scheme vide this Department's letter of even number dated 30.4.2008 and for the clusters and crops and other components approved as per the Annual Action Plan 2008-09 for implementation during 2008-09 by the State/Implementing Agency.
- (b) The implementing agency shall maintain proper accounts of the expenditure incurred and submit the statement of audited accounts and Utilization Certificates to this Department as soon as possible after the close of the financial year.

- (c) The audited records of all aspects (permanent or semi permanent) acquire, wholly or substantially out of the grant to the implementing agency should be maintained as prescribed in the form of GFR 19-A and shall be furnished to the Government of India annually by the end of June, following the financial year to which it relates.
- (d) Assets permanent or semi-permanent acquired wholly or substantially out of the grant by the Government of India shall not, without prior approval of the Government of India, be disposed of, encumbered or utilized for the purpose other than those for which the grant is being sanctioned.
- (e) The accounts of the implementing agency shall be open to Internal Audit of the Principal Accounts Officer, Department of Agriculture & Cooperation as well as the Statutory Audit by the Comptroller & Auditor General of India at his discretion and he shall have the right to demand the production of books, accounts, connected vouchers and other documents and papers in this regard.
- (f) The concerned implementing agency shall furnish the progress report to the Department of Agriculture & Cooperation on Monthly basis in the prescribed format.
- (g) The Implementing Agencies will follow other terms and conditions contained in the General Financial Rules 2005, as amended from time to time.
- (h) Any unspent balance of grant, which is not spent for the purpose for which it is sanctioned during the financial year shall be refunded to the Government of India after the end of the financial year. The funds shall be transferred electronically through RTGS System/Demand Draft to the Implementing Agencies.
